Activation Keys are required to use our Apps. Each App requires its own unique Activation Key to be purchased.

<u>Trial Keys</u>: these are valid for 14 days starting from the moment you register (GMT). At the conclusion of the trial period you will need to acquire a non expiring paid key in order to continue using the App.

<u>Non Expiring Paid Keys</u>: you only need to acquire a key once and it will work in perpetuity for all current and future versions of the App.

Activation Keys are installed and run entirely locally when you configure your App setup. There are no network callbacks to the BaboonBones servers of any kind performed by the Activation Key framework.

Activation Keys may be used by:

- 1) The key purchaser in their own personal Splunk Environments.
- 2) The key purchaser's organization whereby 1 Activation Key is required for each Splunk Node or Splunk Cloud Instance that the App is deployed on or sending data to.
- 3) A Splunk Node is defined as a running process of a Splunk instance type (Heavy or Universal Forwarder , Indexer , Search Head , Deployment Server , Cluster Master , License Master) .
- 4) If you are a Distributor/VAR/Reseller/OEM/Systems Integrator/Professional Services organization/Intermediary of any kind that is purchasing Activation Keys and distributing them to end users, then these licensing requirements also apply.

^{*} Offline Price refers to our standard prices and purchasing via PO/Invoicing/Bank Transfer. Online price refers to paying online at our website with our special discounted Web promotional pricing.

For Offline purchases, your Key(s) will be distributed once payment has been made. In the interim we may provide you with an extended trial key.

If you didn't receive your Activation Key email, it is possible that your spam filters / email security rules blocked 'support@baboonbones.com'. Just email us back at support@baboonbones.com and we'll send out your Activation Key details to another email address you provide that is not blocked.
